- assisting in establishment of joint ventures of various kinds and forms and further legal and informational support.



AGREEMENT ON COOPERATION

between

Vasyl Stefanyk Precarpathian National University (Ivano-Frankivsk, Ukraine)

and

Fujiwara Chemical Co., Ltd (Representative Rotterdam Office)

The Rector of Vasyl Stefanyk Precarpathian National University in Ivano-Frankivsk and the Representative of Fujiwara Chemical Co., Mr. Kimura sign the agreement on the scientific and educational cooperation in the sphere of the mutual relations between the Parties, which states the following:

Art. 1

The collaboration between the Parties will be carried out through submitting to the Vasyl Stefanyk Precarpathian National University Professor Mr. Oleg V. Tkach trainee and practicing possibilities on the base of non profit and not financing. All these points includes:

The Agreement will be valid for one year. At the end of this period this Agreement will be valued or will be discussed due to be prolonged.

Art. 6

The present Agreement comprises equivalent texts in English by two copies. All the texts are identical and have identical legal force.

The agreement comes into force at the moment of its signing.
